- 4. Quotation by fax or by electronic means (are not) acceptable.
- 5. The quotation should be submitted as per the following instructions. The Terms and Conditions of the Work is an integral part of the Contract.
 - a) PRICE: all prices shall be quoted in Ngultrum. The quoted price shall be inclusive of all related costs including taxes, duties and other levies to the final place of delivery, and nothing extra shall be paid. The final place of delivery is (Centre for Bhutan Studies & GNH).
